Summary of relevant experience

I was at school at Wellington College in the 1970's, went to Sandhurst in 1979 and was commissioned into the Irish Guards later that year. I spent 5 happy years with the 'Micks' before leaving in late 1984 to go into industry and join ICI Plc.

This was a tremendous 'grounding' into the world of work outside the Armed Forces, not least because ICI was then a very large and diverse FTSE 100 constituent. When it became clear that I would not be the next Sir John Harvey-Jones (an iconic CEO of his time and former submariner), I left to join the fast-growing management consulting profession. This included several years at KPMG working with and advising industrial companies in the UK before moving into Executive Search, initially with KPMG and then, in 1996, with Korn Ferry International.

I have been on a journey with them ever since. The company was floated (in the US) in 1999 and today is a £3bn revenues global consulting business. My work has centered upon UK Boards (largely in the industrial sector) and working with them to find Chairs, NED's and CEO's and providing ancillary Board services around Board Succession and Performance.

Today I am a Senior Advisor to the Board Practice and the UK business of KF (which employs c 700 people in the UK based out of offices, close to the Club, in St James'). Previously I was a Senior Partner in the Board Practice and managed the EMEA Industry Group. I was also involved in the sale/acquisition of Whitehead Mann LLP in 2008. The work across the Boardrooms of much of 'UK plc' has been fascinating and, dare I say, privileged. It has given me a good deal of insight into how Boards can/should work effectively....and indeed how they should not!

I am therefore hoping that a career 'grounded' in the values that time in HM Forces gives all of us who served, alongside 40+ years in the business world, will enable me to bring some relevant and useful experience to the Board of our unique and special Club.

How I would add value

I live outside London and, since joining the Club in 2010, have used The Rag as a 'home from home', often staying 2 nights p/week. This quite intensive use of the Club has afforded me with a good level of insight into the values and ethos of the Club. A military club with a modern style is a hard balance to achieve. But The Rag has skillfully positioned itself as one such club and one which appears, today, in good financial health and being managed prudently. I would hope to be able to make a contribution as a Board member to keep it 'on track' in this regard.

I believe that the role of a Board member is, as part of the Board, to take decisions in the best interests of the Club and the majority of Members. My business experience as a Director/Partner of a market leading company which works closely with Chairs and Main Boards (plc/private/not for profit) has given me a good insight into how Boards can operate most effectively.
